RE: THE CONSTITUTION OF THE AUSTRALIAN LASER CLASS ASSOCIATION

Further to my letter of 30 October 2009 and our subsequent discussions and emails, may I suggest the following amendments be made to the Constitution of the Australian Laser Class Association:-

1. On page 1 of the Objects, sub-paragraph 4, I suggest that "*Championship*" be made plural because as I understand the intention is to have more than 1 championship.
2. Part 1, paragraph 1 Definitions sub-paragraph (1) delete the reference to "*ordinary member*" as there does not seem to be ordinary members in the association.
3. Part 2 Membership. Delete the first paragraph and replace with "*The Association membership shall consist of the Chairman or President from each of the District Associations recognised by the International Laser Class Association located within Australia namely:*"
4. Part 3, paragraph 15, delete the heading "*Election of members*" and replace with "*Election of members of the Executive Committee.*"
5. Page 12, paragraph 26 Procedure, sub-paragraph (1) delete entirely and re-number subsequent sub-paragraphs accordingly.
6. Paragraph 26, sub-paragraph (4) delete the words "*six members*" and replace with the words "*four (4) members.*"
7. Paragraph 31, Voting on page 14 sub-paragraph (1) delete entirely and replace with the following "*On any question arising at a general meeting of the association each member has one vote only.*"
8. Paragraph 31 Voting, sub-paragraph (3), in the second line delete the words "*second or.*"

9. Part 6 National Events, page 17, paragraph 41 Australian Laser Championship change “*Championship*” to plural “*Championships*.”
10. Paragraph 41, sub-paragraph (1) delete the words “*an Australian Laser Championship*” and replace with the words “*the Australian Laser Championships*.”
11. Paragraph 41, sub-paragraph (2) the first line delete and replace with the following “*The Australian Laser Championships shall consist of the following categories:*”
12. Paragraph 41, sub-paragraph (3) delete and replace with the following “*The events will be held at such places within Australia and at such times as the executive committee shall determine and it shall endeavour to ensure that the six championships are conducted in the same state or territory of the relevant District Association nominated to conduct the championships.*”
13. Paragraph 41, sub-paragraph (4), in the first line delete the word “*event*” and replace with the word “*events*.”
14. Paragraph 41 insert a new sub-paragraph (5) to read “*The District Association shall conduct the championships on behalf of the Association.*”
